### INSTRUCTIONS

Enter an 8-digit state offense code on the Descriptive Report for each offense. Locate the code in this manner: Look in the index below for the major category and page. After locating the major category in the pamphlet, search in the column entitled *Description* for the appropriate offense. The statute number and 5 or more digits of the code will be on the same line as the offense. If only 5 digits are listed you must then select the appropriate NCIC modifier code (located in the same box as the major category heading). The eighth digit is always one of the following:

For example if a suspect is arrested for being an *Accessory to Murder of a Police Officer in the 1st Degree with a Gun*, you would look under *Homicide* and locate the code for *Murder 1st Degree*. That code is 10020. Now check under the *NCIC Modifier* column for the proper description and code. In this case it would be *Willful Kill - Police Officer - Gun*, code .07. Complete the entry by adding code .2, accessory. The full eight digit code is 10020.07.2.
