MISSOURI CHARGE CODE MANUAL INSTRUCTIONS

Enter the four-digit NCIC code with each charge on the front of the fingerprint card. Enter the Missouri statute, U.S. code, or local ordinance number, and Missouri charge code on the back of the card.

Locate these codes in this manner: Look in the index on the following page for the major category and page. After locating the major category in the manual, search in the column entitled *Description* for the appropriate offense. You will find the statute number or U.S. code number, the penal range, five or more digits of the Missouri code, and two or more digits of the NCIC code on the same line as the offense. If only two digits of the NCIC code and five digits of the Missouri code are listed, you must select one of the two-digit modifiers from the range(s) in small print located immediately after the major category description. The eighth digit of the state code is always one of the following:

.0 Not Applicable .1 Attempt .2 Accessory .3 Conspiracy

For example, if a suspect is arrested for being an *Accessory to Murder of a Police Officer in the 1st Degree With a Gun*, you would look under *Homicide* and locate *Murder 1st degree*. The NCIC code is 09 and the Missouri code is 10021. Now check in the modifier range for the proper modifier code. In this case it would be *Willful Kill - Police Officer - Gun*, code 07. The code 07 will be the third and fourth digits of the NCIC code and the sixth and seventh digits of the Missouri code. The eighth digit of the Missouri code will be .2, accessory. This written charge, the NCIC code, the statute number, and the Missouri code are illustrated below in their complete form in their respective prescribed locations.

This manual has been distributed by the Missouri State Highway Patrol. Direct inquiries relating to the codes and their usage to the Criminal Records and Identification Division, Missouri State Highway Patrol, Post Office Box 568, Jefferson City, Missouri 65102, telephone (314) 751-3313.

Missouri Statutes 43.500 through 43.530 RSMo., mandate persons arrested for specific charges be fingerprinted and a description of the arrest charges and a fingerprint card be forwarded to the Criminal Records and Identification Division, Missouri State Highway Patrol, which has been designated as the central repository. This manual has been designed to indicate which charges are reportable and require fingerprints. ONLY THOSE OFFENSES WHERE THE CHARGE CODE IS PRINTED IN RED REQUIRE FINGERPRINTS. Fingerprinting of the individuals arrested for all other charges is at the discretion of the arresting officer or agency.

GUIDELINES FOR UCR CODING

The following definitions were taken from the U.S. Department of Justice, Federal Bureau of Investigation Uniform Crime Reporting Handbook. The definitions are provided to assist in coding arrests.

DEFINITIONS - PART I OFFENSES

1. CRIMINAL HOMICIDE - the willful (nonnegligent) killing of one human being by another.
2. FORCIBLE RAPE - the carnal knowledge of a female forcibly and against her will.
3. ROBBERY - the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.
4. ASSAULT - an unlawful attack by one person upon another.
5. BURGLARY - BREAKING or ENTERING - the unlawful entry of a structure to commit a felony or a theft.
6. LARCENY - THEFT - the unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.
7. MOTOR VEHICLE THEFT - the theft or attempted theft of a motor vehicle.
8. ARSON - any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

DEFINITIONS - PART II OFFENSES

9. OTHER ASSAULTS - assaults and attempted assaults where no weapon was used or which did not result in serious or aggravated injury to the victim.
10. FORGERY & COUNTERFEITING - all offenses dealing with the making, altering, uttering, or possessing, with intent to defraud, anything false in the semblance of that which is true.
11. FRAUD - fraudulent conversion and obtaining money or property by false pretenses.
12. EMBEZZLEMENT - misappropriation or misapplication of money or property entrusted to one's care, custody, or control.
13. STOLEN PROPERTY: BUYING, RECEIVING, POSSESSING - all offenses of buying, receiving, and possessing stolen property, as well as all attempts to commit any of these offenses.
14. VANDALISM - consists of the willful or malicious destruction, injury, disfigurement, or defacement of any public or private property, real or personal, without consent of the owner or person having custody or control.
15. WEAPONS: CARRYING, POSSESSING, ETC. - weapons offenses, regulatory in nature, such as: manufacture, sale, possession, using or carrying deadly weapons or silencers or attempts to commit any of these.

16. PROSTITUTION & COMMERCIALIZED VICE - sex offenses of a commercialized nature, such as: prostitution, keeping a bawdy house, pandering, procuring, transporting, or detaining women for immoral purposes, etc., and attempts to commit any of these.
17. SEX OFFENSES - offenses against chastity, common decency, morals, and like, and attempts to commit these (except forcible rape, prostitution, and commercialized vice).
18. DRUG ABUSE VIOLATIONS - all arrests for violations relating to the unlawful possession, sale, use, growing, manufacture, and making of narcotic drugs.
19. GAMBLING - all charges which relate to promoting, permitting, or engaging in illegal gambling.
20. OFFENSES AGAINST THE FAMILY AND CHILDREN - all charges of nonsupport and neglect or abuse of family and children, such as: desertion, abandonment, nonsupport, neglect, nonpayment of alimony, and attempts to commit any of these.
21. DRIVING UNDER THE INFLUENCE - the driving or operating of any vehicle or common carrier while drunk or under the influence of liquor or narcotics.
22. LIQUOR LAWS - except drunkenness or driving under the influence, include liquor law violations such as: manufacturing, sale, transporting, furnishing, possessing, etc.
23. DRUNKENNESS - all offenses of drunkenness or intoxication, with the exception of driving under the influence.
24. DISORDERLY CONDUCT - all charges of committing a breach of the peace.
25. VAGRANCY - charges of being a suspicious character or person including begging, loitering, etc.
26. ALL OTHER OFFENSES - include all other offenses (except traffic violations) not included in the other categories.
27. SUSPICION - limited to "suspicion" arrests where persons arrested are released by police.
28. CURFEW & LOITERING LAWS (PERSONS UNDER 18) - local curfew or loitering ordinances where such laws exist.
29. RUNAWAYS (PERSONS UNDER 18) - include apprehensions for protective custody for local statute but not for protective custody actions taken for other jurisdictions.
