DESCRIPTION: This Fingerprint Technician position is assigned to the Missouri State Highway Patrol's Criminal Justice Information Services Division. *This position is assigned to the 3rd shift - 10:30 p.m. to 7:00 a.m. An employee in this position will work rotating weekends and holidays.* The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: An employee in this position performs advanced technical and complex work involving the classification, searching, comparison and filing of criminal and applicant fingerprints. An employee in this position will participate in an on-the-job training program and attend and successfully complete certification classes pertaining to the job. The employee exercises independent judgment and initiative in the performance of the assigned duties; however, general supervision is provided by the immediate supervisor to ensure conformance with established rules, policies and procedures. QUALIFICATIONS: **Fingerprint Technician I:** Graduation from high school or possess a GED. **Fingerprint Technician II:** Graduation from high school or possess a GED and at least one-year experience as a Fingerprint Technician I or comparable experience. **Fingerprint Technician III:** Graduation from high school or possess a GED and at least two years experience as a Fingerprint Technician II or comparable experience.

SALARY RANGE: The minimum starting salary is \$1,024.00 (semi-monthly); however salary may be commensurate with applicable experience and education.

APPLICATION PROCEDURE: Individuals interested in this Fingerprint Technician position, **must submit** the Patrol's on-line application prior to the application deadline of July 1, 2011. Resumes will not be accepted in lieu of the application. Please visit our website at www.mshp.dps.mo.gov to complete an **on-line** Application for Civilian Employment (ACE). *A typing test score of 40 wpm w/ 10 or less errors, which can be completed at www.assesstyping.com/test/start?accountid=mshp-hrd, must be achieved to be considered for the position of Fingerprint Technician.*

Individuals who have completed a paper application for a position within the last twelve months must complete a new on-line application in the ACE system.

Current Patrol employees who meet the minimum qualifications may apply through the Human Resources Division by submitting an intradepartmental letter of application and resume through channels prior to the application deadline.

Interview boards are tentatively scheduled for the week of July 11, 2011. The tentative start date for this position is within 30 days of the interview.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
