Housekeeper II: Graduation of the eighth grade AND possess at least one-year experience as a Housekeeper I or comparable experience. Housekeeper III: Graduation of the eighth grade and possess at least one-year experience as a Housekeeper II or comparable experience.

**SALARY RANGE**: (Semi-monthly) The minimum starting salary is \$810.00; however salary may be commensurate with experience.
