TITLE: Temporary Clerk **(Variable shifts to include evenings, weekends, and holidays)**

LOCATION: General Headquarters, Jefferson City, MO

DESCRIPTION: There are currently two Temporary Clerk positions available within the Missouri Information Analysis Center of the Missouri State Highway Patrol. The official domicile is Jefferson City, Missouri. These positions are classified as non-exempt under the Fair Labor Standards Act. *These positions are approved for 1,000 hours of work during a 12-month period.*

POSITION SUMMARY: This is entry level to advanced level temporary work in which the individual analyzes and assesses criminal information of a confidential nature via specialized analytical and informative state and federal databases. The employee is responsible for disseminating information to appropriate personnel and outside agencies. Work is performed under general supervision. *(For a more detailed job description go to:*

QUALIFICATIONS: Must be a high school graduate or possess a GED. Preference may be given to applicants who possess a Bachelor Degree in criminal justice, or related field; or 4 years of comparable technical or analytical experience in a criminal justice agency, military agency, or related field.

Applicants must successfully complete Foundations of Intelligence Analysis Training (FIAT) within a period not to exceed six months after appointment (or as soon as course enrollment is available). Applicant must be a resident of Missouri at the time of appointment. Applicant must pass a comprehensive background check necessary to have access to criminal intelligence and other information in the Missouri State Highway Patrol. Applicant must obtain a secret level Department of Homeland Security background/clearance or other federal background/clearance of equal security level.

SALARY RANGE: Hourly salary may be commensurate with applicable experience and education.

APPLICATION PROCEDURE: Individuals interested in these positions **must complete and submit** the Patrol's on-line application. Resumes will not be accepted in lieu of the application. Please visit our website at www.mshp.dps.mo.gov to complete an **on-line** [Application for Civilian Employment \(ACE\)](#).

The tentative start date for these positions is within 30 days of the interview.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature. A copy of the Missouri State Highway Patrol policy on sexual harassment is available upon request.

NOTE: Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations and/or candidate's possession of the knowledge, skills and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a Patrol administered drug test and favorable background investigation.
