

Through The Eyes Of A Child

In between coordinating logistics, people, and equipment and conversations with a local radio station, arranging advertisements for the Career Expo, my phone rang. I almost declined the call; however, the caller was my mother. Like a good son, I answered the phone and began to have a quick conversation with her and my son, who was talking in the background. I told them all about the day and how the Career Expo was going.

My son, a naturally curious five-year-old, asked, "What is a Career Expo?" After hearing my answer, he asked, "Can I come to the Career Expo, Dad?"

I thought about it for a second and said, "Of course. I know a good tour guide." Five minutes later, my mom dropped him off and we started our tour.

As we began our tour, he naturally gravitated to the helicopter parked in the front parking lot. The pilots greeted him with smiles. His face lit up as he jumped into the cockpit and began to move the controls. We moved from station to station greeting all the smiling faces. It was incredible to see his awe-filled reactions to all the people and different equipment. It was truly a kid-in-a-candy-store moment. It was obvious he viewed everyone there as larger-than-life superheroes ... Dad included. The tour reminded me of myself, when I came to the Patrol, excited for the adventure and ready to make a difference.

He tried on the Dive Team equipment, all 40+ pounds of it. Luckily, he had plenty of help to hold it up. He gravitated toward the River Pro patrol boat and was awed by how much more, "cool," the Patrol's boat is compared to ours. He scrambled into the SWAT team's Bearcat and said, "This thing is like a tank!" The Bomb Squad members answered, "What's that used for?" as he explored their equipment thoroughly. The new robot looked, "like a big, remote-controlled car."

Big Blue, the Patrol's Communications Command Center, was hard to miss in the parking lot, and my son was understandably drawn to the monitor on the side. He went up the steps and was impressed by its size. I myself was a little nervous and advised him, "Don't touch anything!"

I enjoyed seeing his awe at the Patrol's specialized equipment. I see a similar reaction from many of our applicants when they learn about the exciting career opportunities within the Patrol. As I speak with potential applicants and see their curiosity move to excitement, their reaction is contagious.

With 15 years of experience, it's a good reminder of why I chose and love this career.

Technically, the Career Expo was not a "Take Your Kid To Work Day," and it only lasted about 15 minutes. But those spontaneous 15 minutes were better than anything I could have planned. Since the event, my son has asked questions about the Patrol quite often and understands more about my career. Who knows? Maybe his questions will lead him to a career with the Missouri State Highway Patrol.

Recruiters are continuously out in the field throughout the state looking for the best and brightest. Captain Jason M. Pace (Q/RCOD) had an idea: Why not bring them to us? Why not host an event at General Headquarters that would allow potential applicants to speak directly to employees about their prospective expertise?

When I transferred into the Recruiting & Community Outreach Division, one of my first conversations with Capt. K9 CIPO RETIRES

At nine years old, he can boast quite a career. He was trained in article and evidence searches, as well as locating illegal drugs. On December 1, 2022, K9 Cipo (pronounced See-Po) retired after seven and a half years of service. He was a key part in numerous seizures, including several 100-pound marijuana seizures, weapons, methamphetamine, and cocaine.

One notable find was an assault rifle thrown from a vehicle being pursued by a trooper. “We had been called out to assist with the search,” said Cipo’s handler, Sergeant Mark A. Wilhoit (H). “I deployed Cipo and worked him along the road. It was dark and I only had a flashlight. Cipo alerted to the weapon then sat down and stared just like he was supposed to do. I was looking with a flashlight trying to see what he was alerting to. After a few minutes, I moved my light to a different angle in the brush and could see the black rifle barrel stuck in the mud like a yard dart.”



Sgt. Wilhoit said Cipo is definitely a working canine, but he was good around family, too. “Cipo’s personality is great. He liked to swim in our pond and would frequently jump in the pond and cool off in the warm months,” he said.


Cipo participated in numerous manhunts and tracks. He was involved in numerous arrests and although he came close several times, Cipo never needed to restrain a suspect with a bite ... the suspect gave up before getting bit.

Sgt. Wilhoit and Cipo were partners since May 2015, when the Patrol acquired the K9 from Riverview

Friends and family of the 115th Recruit Class braved unusually cold temperatures to attend graduation December 11, 2022. With heads held high, 19 people entered the Patrol's Law Enforcement Academy and marched to their seats. After 25 weeks of intense training, they were about to reach their goal of becoming Missouri State Highway Patrol troopers. However, before they said their Oath of Office, there were a few other items of business.

The Troop F color guard presented the flags, and soon-to-be Trooper Timothy J. O'Sullivan, a member of the 115th Recruit Class, sang the national anthem. Pastor Donald Carson, First Church of God, provided the invocation and benediction.



Five-Minute Stop Yields Huge Meth Stash

On November 29, 2022, Corporal Timothy A. Barrett (D) was working traffic on Interstate 44. He was stationary when he observed a large sport utility vehicle traveling visibly faster than other traffic. When the vehicle passed his location, Cpl. Barrett checked its speed by radar, which indicated the vehicle was traveling 76 mph in a 60-mph zone. Cpl. Barrett caught up to the vehicle and stopped it at the 82-mile marker. When the driver began telling Cpl. Barrett a story that didn't quite match what he could see in the vehicle, he asked the driver for consent to search. The driver was quick to consent and opened the hatch to reveal the three large moving boxes. The more than 170 pounds of methamphetamine, three guns, and small amount of cocaine in the boxes was then seized and the driver arrested. (Interesting side note: Two of the guns were 3-D printed guns, thus had no serial numbers.)

K9 James was with his partner at the time of the stop, and enjoyed being in the photos. However, the case was made on consent. "A canine presence does tend to change people's behavior whether they are deployed or not," said Cpl.

Barrett. "It was a relatively quick case, maybe five minutes from stop to arrest. We didn't try to make it happen fast; it just fell in our lap that way. It's a relatively short story for such a large seizure."

Excellent work, Cpl. Barrett!

I was fortunate enough to be selected to attend the 7th Police Leadership - The West Point Model (PLWM) Class this past fall. Over the course of the training, we learned about ourselves, our teams, and the organization. During week one, we dove into leadership, attributions, biases, equity, cognitive evaluation, job design, integration, motivation, individual differences, expectancy, motivation, and followership. Week one focuses on oneself and how you fit into the equation of what your role is at the Patrol. This really opened my eyes to differences between individuals, and how each of us plays a vital role ensuring we meet our vision and mission.

During week two we explored groups, which included topics such as group structural dimensions, socialization, group decision making, cohesion, and transformational leadership. Transformational leadership was impactful and a great lesson for the current and future leaders of our organization. In addition, we learned that leadership is far deeper than just obtaining a title. When we are leading, we are leading people. As leaders we need to invest in our people and ensure that they are successful in their positions, while meeting the goals of the organization. Whether positively or negatively,

always keep in mind that as leaders you are impacting the future of your people.

During week three, we explored topics related to the organization, such as stress and resilience, culture, ethical climate, leading change, and communication and counseling. The impact each of us have for this organization, whether you are a civilian or a member, is huge. We must keep the foundation of our agency strong through living our core values, vision, and mission every day. While none of us are perfect, I take great pride in the fact that our organization has a culture facilitating the public's well-being. I also take great pride in the fact that we, together, make

Missouri a safer place to live and visit.

I was surprised by the opportunities for growth attending PLWM revealed, not only for myself, but the organization as well. A unique aspect of this training was to have attendees from other agencies. We heard different perspectives from around the country and gained insight that we otherwise would not have had. For myself, the most beneficial aspect of PLWM was bringing members and civilians together to learn from one another. The open dialogue of the course facilitated deep conversations that may otherwise not be had elsewhere within the Patrol. We were able to interact with one another and get to know

each other for who we are, rather than our titles. The relationships forged during PLWM will last a lifetime. If you are looking for a challenge, something different, and an opportunity to make an impact in this organization, I would encourage you to attend PLWM. If you are open to the process, this course will impact your life.


Multi-State Investigation Leads to Arrests

On Saturday, November 19, 2022, a Missouri State Highway Patrol trooper attempted to stop a vehicle on Interstate 70 near Grain Valley, MO. The vehicle failed to yield, and a pursuit ensued. During the pursuit, the suspects fired several rounds toward the trooper with one striking his patrol car. Neither the trooper nor any innocent bystanders were injured. The suspect vehicle was subsequently recovered and determined to be stolen.

A lengthy investigation led to three suspects being identified. The suspects were apprehended both in Kansas City, MO, and Rawlins, WY, in three separate incidents. In addition to these individuals, associates of the suspects were identified. These associates had assisted the original suspects' flight from law enforcement. A total of eight individuals were arrested on felony charges, three stolen

vehicles were recovered, two stolen handguns were located, and three suspects were charged with possession of methamphetamine. Over a dozen outstanding arrest warrants were served.

The Blue Springs (MO) Police Department, Kansas City Career Criminal Task Force, Kansas City (MO) Police Department, Carbon County (WY) Sheriff's Department, Rawlins (WY) Police Department, Wyoming Division of Criminal Investigation, and Dickinson County (KS) Sheriff's Office assisted with this investigation. The interagency cooperation during this investigation led to its success.

TROOP D HONORS CITIZEN HEROES

Occasionally, an extraordinary thing happens in a place where extreme circumstances and selfless humans collide. It is in this place that heroism, born from ordinary people, is given the opportunity to be released, creating a situation where ordinary people put themselves in harm's way for the good of someone or something else. These are instances where the trajectory of lives is changed or a course is altered. It's the kind of thing troopers do every day. However, this story is an account of an incident where two citizens, strangers initially, displayed fierce resolve in their attempt to save lives.

It was just after noon on July 5, 2022. Mr. Richard Mogan was driving to his home in Eldorado Springs, MO, from Springfield, MO. He had just left the doctor where he had received another round of radiation. This was his 21st consecutive daily trip for treatment. Traveling north on four-lane Missouri Highway 13 in Greene County, Mr. Mogan's car, a Mazda Tribute, traveled off the road and into the median. Mr. Mogan was in cardiac arrest and was unconscious. The grassy void between the lanes only slowed the car as it continued toward the southbound lanes.

Among all the drivers traveling along MO Highway 13 that day, at that precise time, were two unconnected drivers, who witnessed the scene unfold and recognized a serious situation. Kevin Jeffries, a truck driver from Blue Springs, MO, stopped

his truck along the northbound shoulder ahead of the moving car. Justin Parrack, a Fabick mechanic from Cross Timbers, MO, parked his vehicle along the same shoulder. Both got out and ran to intercept the moving vehicle. Each believed a medical issue to be occurring and committed to resolving it. As they ran along beside the car, they attempted to wake Mr. Mogan who was unresponsive and lying across the console toward the passenger seat. They tried to access Mr. Mogan

on the passenger side, but were thwarted by locked doors. Kevin and Justin ran to the driver's side as Mogan's car was exiting the median and encroaching the southbound passing lane. Oncoming traffic was taking evasive action to avoid colliding with the out-of-control Mazda and the two men trying desperately to stop it. After opening the driver's side door, the two gentlemen gained access to the passenger compartment, steered the car back onto the grass, got it stopped, and placed the vehicle in park.

After parking the vehicle, Justin and Kevin noticed Mr. Mogan was not breathing and extricated him from his car. They began cardiopulmonary resuscitation until the arrival of Ebenezer Fire district personnel. Emergency services personnel continued to administer CPR as he was transported by ambulance to

Mercy Hospital in Springfield.

Time goes by and life marched on. Both Kevin and Justin probably paused from time to time wondering how things turned out for the stranger they helped along the highway back in July. What they didn't know was Mr. Mogan had clinically died—twice. Once while driving home and again in the emergency room of Mercy Hospital. They were unaware that it was their heroic efforts that ultimately gave him another go at life.

On December 2, 2022, Richard Mogan's daughter, Lesa, shared this story in the front lobby of

Troop D Headquarters moments before they would meet Kevin and Justin for the first time. Richard, still bouncing back from the ordeal, sat beside her smiling and nodding. Richard, Kevin, and Justin along with their respective guests, were invited to an Honorary Trooper award ceremony to recognize the exemplary acts of these two men. Sergeant Mike K. Frazier (D), who had responded to the crash scene, submitted a written award request for consideration to Colonel Eric T. Olson, and it was approved. Troop D commanding officer, Captain D. Scott Sater presented Kevin

and Justin with the awards after the account of their heroism was shared with those in attendance. Two media outlets were present to document the reunion and several Patrol employees, guests, and family attended to witness something good—something rare. It was an opportunity to celebrate life and reflect on “what-could-have-been” had both extreme circumstances and these individuals not collided.

(Editor's note: Richard Mogan is now in remission and no longer requires radiation treatment for cancer.)

In the story, Sgt. Rod Land (Q/TND) indicated the swap was necessary because the current weapon experienced many broken parts.

10 years ago

January/February 2013 — The cover showed a banner declaring, “It only takes three seconds to Buckle Up, but DEAD is FOREVER. Please ‘Click it 4 Life.’” The banner greeted spectators as they arrived at Hannibal High School for a basketball game during the playoffs.
