In June 1996, I was notified of my selection to enter recruit training. The letter provided a lot of information and suggested some form of stress management training was provided during orientation. I recall many things about the first day of recruit training, like misplacing my lanyard; being directed to go find the missing lanyard and forgetting my hat; returning to the classroom to retrieve the forgotten hat to find Lieutenant Chris T. Ricks parading around the classroom wearing my hat; and then mistakenly referring to Captain B. Chris Baker as a lieutenant. Oh, I recall managing stress during the first day of recruit training, but no recollection of any stress management training.

Fast forward to today and the topics of stress management, workplace wellness, and employee well-being have expanded greatly. All peace officers are now required to meet with a program service provider once every three to five years for a mental health check-in. We have a proactive, trained, Peer Support Team to provide peer-driven support services along with Critical Incident Stress Management assistance services. Our awareness of the impacts of stress have improved greatly; however, there remain barriers that prevent employees from getting the help they may need.

Finding ways to further support the safety, health, and wellness of every employee is the reason we invested in the Cordico Wellness app. Cordico's wellness solution will provide all Patrol employees, retirees, and their family members with on-demand access to wellness resources. The app contains videos, articles, and guides on financial fitness, healthy habits, nutrition, and much more. Cordico's wellness tools and self-assessments are designed to keep personnel healthy and effective at work and at home.

The Center for Disease Control describes well-being as the ability of individuals to address normal stresses, work productively, and realize one's highest potential. Once available, I encourage you to explore the Cordico app and realize your highest potential.



Cpl. Lairmore Rescues Driver In Danger

A trooper can work their entire career and never quite be in the right place at the right time to save someone's life. At 5:40 a.m. July 27, 2022, Corporal Louis B. Lairmore (Q/GD) had that opportunity. He was in an unmarked vehicle and in civilian attire while he commuted to work at Bally's Casino during a torrential downpour on northbound Interstate 435 in Kansas City. Cpl. Lairmore came upon the scene of a four-vehicle traffic crash that had just occurred. One vehicle was on the concrete median wall of the bridge over a railyard. The vehicle was perched precariously with both driver side wheels hanging over the wall. Cpl. Lairmore activated his emergency equipment and stopped behind the vehicle. The initial concern was the driver might attempt to exit the vehicle and fall to his death more than 100 feet below.

Cpl. Lairmore attempted to contact the driver, who was disoriented and unaware of his surroundings. Both doors on the right side of the vehicle had been wedged into the vehicle frame. The right front door would not budge. In the pouring rain, Cpl. Lairmore coached the driver to climb carefully into the back of the vehicle. He then forced the

right rear door open and pulled the driver from the vehicle. Cpl. Larimore escorted the driver to the safety of his patrol vehicle. Prior to local responders and police arriving, Cpl. Lairmore prevented this disoriented motorist from exiting his vehicle and falling from the bridge. He also removed the possibility of the driver being injured if the precariously positioned vehicle was struck by another vehicle and plunged from the bridge. Tragically, only yards away, another motorist who exited his vehicle fell over the median wall to his death.

On January 10, 2023, Cpl. Lairmore, accompanied by his wife, Maggie, accepted the December 2022 DPS Sworn Team Member of the Month during a ceremony at General Headquarters. Department of Public Safety Deputy Director Kevin Bond and Colonel Eric T. Olson presented the award.

"Corporal Lairmore's commitment to service and the safety of others was exemplified by his actions on July 27, 2023," said Col. Olson. "We are all very proud of how he handled this difficult situation."

Chiefs Kingdom Welcomes Troopers

The Kansas City Chiefs victory parade welcomed approximately one million people on Wednesday, February 15, 2023. Approximately 50 Patrol personnel were assigned to the parade in downtown Kansas City, MO. At the request of the Kansas City (MO) Police Department, the Missouri State Highway Patrol assisted with pedestrian traffic safety along the parade route. Additional Patrol employees performed other duties such as governor security, emergency operations center overwatch, undercover surveillance, radio communications, and logistical support. The Patrol

worked collaboratively with nearly 20 different agencies. Communications personnel ensured our troopers were able to communicate with each other and the various agencies. Due to the scope of the event, interoperability was vital for the safety of the citizens as well as the officers assigned to the detail.

“The Victory Parade detail was an excellent opportunity to work side-by-side with other law enforcement agencies,” said Capt. Steve V. Wilhoit (A). “Our troopers were on showcase, standing along the entire length of the parade route. Our men and women served this detail with professionalism and compassion, ensuring the safety and fun for everyone. It was a sight to see.”

Troopers assigned to the parade route had to be on their post no later than 6:30 a.m. The parade began at 11:30 a.m. at Berkley Park near Second and Grand Avenue. The parade moved south on Grand Avenue to Pershing Road then traveled west on Pershing Road to Main Street, ending at Union Station where the celebration rally

took place at approximately 1:30 p.m. Troopers remained at their posts until approximately 4 p.m. to ensure a safe and secure environment for all attendees.

Throughout the detail, troopers interacted with thousands of spectators and endured the elements. It wasn't as cold as the 2020 victory parade, but with a sustained wind of 15 mph and an occasional 30 mph wind gust, many layers were necessary to remain

Traffic Stop Leads To Arrest

Corporal Eric L. Mueller (D) was honored with the DPS Sworn Member for the month of January 2023 related to a traffic stop which led to the arrest and conviction of a subject who was in possession of child pornography. A ceremony took place January 26, at Troop D Headquarters in Springfield, MO.

At approximately 6:29 a.m. July 28, 2020, Cpl. Mueller observed a white 1998 Ford F-150 pass his location on westbound U.S. Highway 60 in Webster County, MO. The Ford displayed expired Missouri license plates, which gained Cpl. Mueller's attention. After the Ford passed his location, he overtook the vehicle and initiated a traffic stop.

Through computer checks, Cpl. Mueller determined that the driver was a registered sex offender in Missouri, having been convicted of possessing child pornography. Cpl. Mueller also determined that the vehicle he was driving was not listed on his registry. After the computer check, Cpl. Mueller returned to the driver and questioned him about his phone, social media accounts, and the existence of any illegal photographs. Without further prompting, the driver opened his cell phone photo gallery and displayed several images of what appeared to be underage girls.

Cpl. Mueller arrested the driver, who was later charged and convicted of felony possession of child pornography. The man was sentenced to 15 years in prison.

“Corporal Mueller’s work in this case is a great example of the importance of delivering high quality law enforcement services to the citizens of Missouri, one traffic stop at a time,” said Colonel Eric T. Olson. “I commend him for his attention to duty and adherence to the Patrol Core Values.”

K9 Zsolti Retires!

Congratulations to K9 Zsolti upon his retirement March 1, 2023. Zsolti joined the Patrol in May 2020 after training at Riverview Canine in Cape Girardeau, MO. During his career, Zsolti deployed 104 times (including 62 vehicle sniffs) and performed 34 tracks, 13 call-outs, and two building searches, and made four apprehensions. He assisted in the seizure of 825.1 pounds of marijuana, 98.13 pounds of methamphetamine, 6.25 pounds of hashish, 2.2 pounds of cocaine, 56 opioid pills, and smaller amounts of heroin, edibles, MDMA, and THC concentrate. Zsolti sniffs also yielded two weapons and \$322,440 in U.S. currency. His partner, Sergeant R. Brooks McGinnis (A) said in retirement, Zsolti will most likely try to play with and annoy his replacement in the program. Thank you for your service, K9 Zsolti.

Finding Support thru Faith, Family, & Community

Lead Pastor Phil Hoper, a former police sergeant and SWAT team member with the Kansas City (MO) Police Department, hosted the event. This was a special opportunity for those present to hear a former police officer's story about the many seasons of life he and his family endured, both the better and the worse.

(A) greeted each spouse as they arrived. Several wives were familiar with each other; a few were new to the group. When it was time to get started, Capt. Wilhoit introduced Pastor Phil and thanked each spouse for their commitment. Additionally, Pastor Phil's wife, Christa, joined everyone to share her perspective as a former law enforcement spouse.

Pastor Phil and Christa were transparent when speaking about their experiences and his eight years with KCPD. His police career included a variety of demanding assignments and difficult schedules. He spoke about the struggle of dividing time and energy between the police department and his family. Christa shared a story about going into labor with their second child while Pastor Phil was at an emergency SWAT operation. Their son was already born before Pastor Phil received word she was in labor.

"Despite the many challenges while [I was] with KCPD," said Pastor Phil, "I never lost hope."

Pastor Phil said he entered the law enforcement profession as a Christian, worked every assignment and shift as a Christian, and never shied away

from an opportunity to share the gospel. Pastor Phil told a story of a particular officer he was partnered with during his time working the overnight shift. This officer was going through a divorce and struggling with several aspects of his life. Pastor Phil spoke to him about living as a Christian, but the officer was reluctant to surrender to God and accept Jesus Christ as his savior. The partnership continued for many days, weeks, and months, and the officer came to Pastor Phil and asked him for help understanding and knowing Christ. Soon after they began talking about God, the officer accepted Jesus Christ as his savior. The officer went on to fix his brokenness and save his marriage.

Before leaving KCPD, Pastor Phil was recognized with the Distinguished Service Award, the department's second-highest honor; the Channel 9 Gold Award for Valor (local television station); and was named one of the National

DPS Honors Weddle, Blackston

On February 15, 2023, Colonel Eric T. Olson and DPS Director Sandra K. Karston presented Sergeant Greg A. Weddle (I) and Corporal Shawn M. Blackston (I) with the DPS Sworn Team Member of the Month award for February 2023. This recognition stemmed from a traffic stop conducted by Sgt. Weddle in October 2022. Sgt. Weddle stopped a vehicle for a traffic violation at the end of his shift. After the driver failed to produce proper identification, Sgt. Weddle requested assistance from Cpl. Blackston and his assigned fingerprint scanner.

The driver was identified and a warrant for her arrest was discovered. The warrant entry also had an attached missing person entry for an abduction that occurred 13 years prior in the state of Texas. During the investigation, it was determined that the abducted child, now 17 years old, was safe at a location in the St. Louis area. The child and his father were reunited after 13 years.

Sgt. Weddle and Cpl. Blackston's efforts revealed the importance of 'looking beyond'

during a traffic stop. We have all had those instances at the end of our shifts where getting home to our family is of utmost priority. Sgt. Weddle took the additional time at that last stop and reunited a father and son after 13 years of separation.

"I couldn't be more proud of Sgt. Weddle and Cpl. Blackston for their actions in this case," said Captain Eddie A. Blaylock (I). "They are such hard workers

and this incident shines a light on the importance of enforcing simple traffic violations and what they can lead to. Sgt. Weddle made that one last traffic stop on his way home to secure, which led to great interviewing and follow up by him and Cpl. Blackston. As a result, a young man was reunited with his father and family after nearly 14 years. We are so proud of Greg's and Shawn's actions that evening. They changed the lives of an entire family forever!"

Patrol History Trivia

Chicken-napping Case Solved!

This report does not indicate in what year the incident occurred, but the troopers named point toward it happening in the agency's early years. It's originally titled, "Statement as to the number of chickens found, where and when found, and how returned to Mrs. South."

Friday, September 30, Sheriff Bert Wheatley, Patrolman J.F. Judkins, Patrolman Herb Brigham, Ned Young, and Jeff Taylor went to Frank Spencer's farm in Jackson County. There, the men caught three buff Orpington chickens. Sheriff Wheatley went over to a nearby field where a man was sowing wheat. Sheriff Wheatley brought the man back to Frank Spencer's farm and Ned Young, Patrolman Judkins, and Sheriff Wheatley went over to the man's house to talk to his wife. Patrolman Brigham and Jeff Taylor stayed at the Frank Spencer farm. Then, Sheriff Wheatley came back to Frank Spencer's farm and Ned Young and Patrolman Judkins went to Spencer's Cafe, leaving Sheriff Wheatley, Jeff Taylor, and Patrolman Brigham at Spencer's farm. Ned Young and Patrolman Judkins got Mr. & Mrs. Frank Spencer at their cafe and brought them back with them to Frank Spencer's farm.

Sheriff Wheatley and Jeff Taylor took Mr. and Mrs. Frank Spencer in Sheriff Wheatley's car and went back to Spencer's Cafe on [Missouri] Highway 71. Ned Young, Patrolman Judkins, and Patrolman Brigham came to Frank Spencer's Cafe in Patrolman Judkins' car. Mr. and Mrs. Spencer got the Spencer car ready and Mrs. Frank Spencer drove her car to the Highway Patrol station at Lee's Summit. Sheriff Wheatley and Jeff Taylor followed Mrs. Spencer in Sheriff Wheatley's car to the Patrol station at Lee's Summit.

Patrolman Judkins, Patrolman Brigham, and Ned Young searched the Frank Spencer Cafe and found 27 buff Orpington chickens in the basement of the cafe. They searched the Frank Spencer Cafe at the invitation and consent of one Gene Frost, who was employed there, just after the arrest of Mr. and Mrs. Frank Spencer at the cafe. The three buff Orpington chickens found at the Frank Spencer farm previously were in a sack in Patrolman Judkins' car. The three buff Orpington chickens found at the Frank Spencer farm plus the 27 buff Orpington chickens found in the basement of Frank Spencer Cafe made a total of 30 buff Orpington chickens accounted for. Virgil Dill, who worked for Mr. and Mrs. Frank Spencer, stated that

five or six buff Orpington chickens had been killed the morning of September 30th for use in the cafe.

The night of October 1st, Sheriff Wheatley returned to the Frank Spencer farm and found five more buff Orpington chickens. This made a total of 35 buff Orpington chickens recovered at the Frank Spencer farm and in the basement of the Frank Spencer Cafe. Along with the five or six buff Orpington chickens killed and cleaned for use in the cafe, a final total of 40 or 41 buff Orpington chickens were accounted for on the night of September 30th. Patrolman Judkins, Patrolman Brigham, and Ned Young brought 12 buff Orpington chickens to the Highway Patrol station at Lee's Summit, leaving 18 buff Orpington chickens in the basement of Frank Spencer's Cafe. Sheriff Wheatley and Patrolman Judkins returned to the cafe and brought back the other 18 buff Orpington chickens to the Highway Patrol station at Lee's Summit. These 30 buff Orpington chickens were brought by Sheriff Wheatley to the home of Mrs. Charles South and left with Mrs. Charles South. The following night of October 1st, Sheriff Wheatley and [Ned] Young went to the Frank Spencer farm, got the other five buff Orpington chickens, and returned them to the home of Mrs. Charles South and left them with her.

“Jason is a great, first CVO Of The Year for all he does, said Capt. Kelley. “The division can’t accomplish our goals without our commercial vehicle officers in the field. Our employees are the backbone of the Patrol and the CVE division.”

On February 27, 2023, the buzz of conversation and muted laughter throughout the room indicated something was happening. The DPS Nonsworn Team Member of the Month ceremony was about to begin, and employees had gathered to congratulate Public Information Specialist III Meghan E. Basinger (Q/PIED), who was being honored with the February 2023 award.

Major Corey J. Schoeneberg (Q/ASB) welcomed everyone and thanked them for coming. He then shared the nomination and congratulated Meghan.

The female stated she had been in a traffic crash earlier, that her depression was “90 times worse,” and that she was having “some very bad thoughts.” Ms. Basinger then utilized information in the email to identify the female through her social media accounts. Another email from the female indicated she was suicidal. Utilizing the information provided by the female and Ms. Basinger, the Patrol was able to determine the traffic crash occurred in the Troop I, Rolla, MO, area. The information was forwarded and Troop I and the Rolla Police Department developed further information, identified the female, and located her. Ms. Basinger’s actions allowed personnel in Troop I to take the appropriate action to help a person in need and prevent a tragic conclusion. Ms. Basinger’s attention to detail, dedication to her duties, and her strong work ethic led to a positive outcome to what could have been a tragic loss of life.”
