Introduction

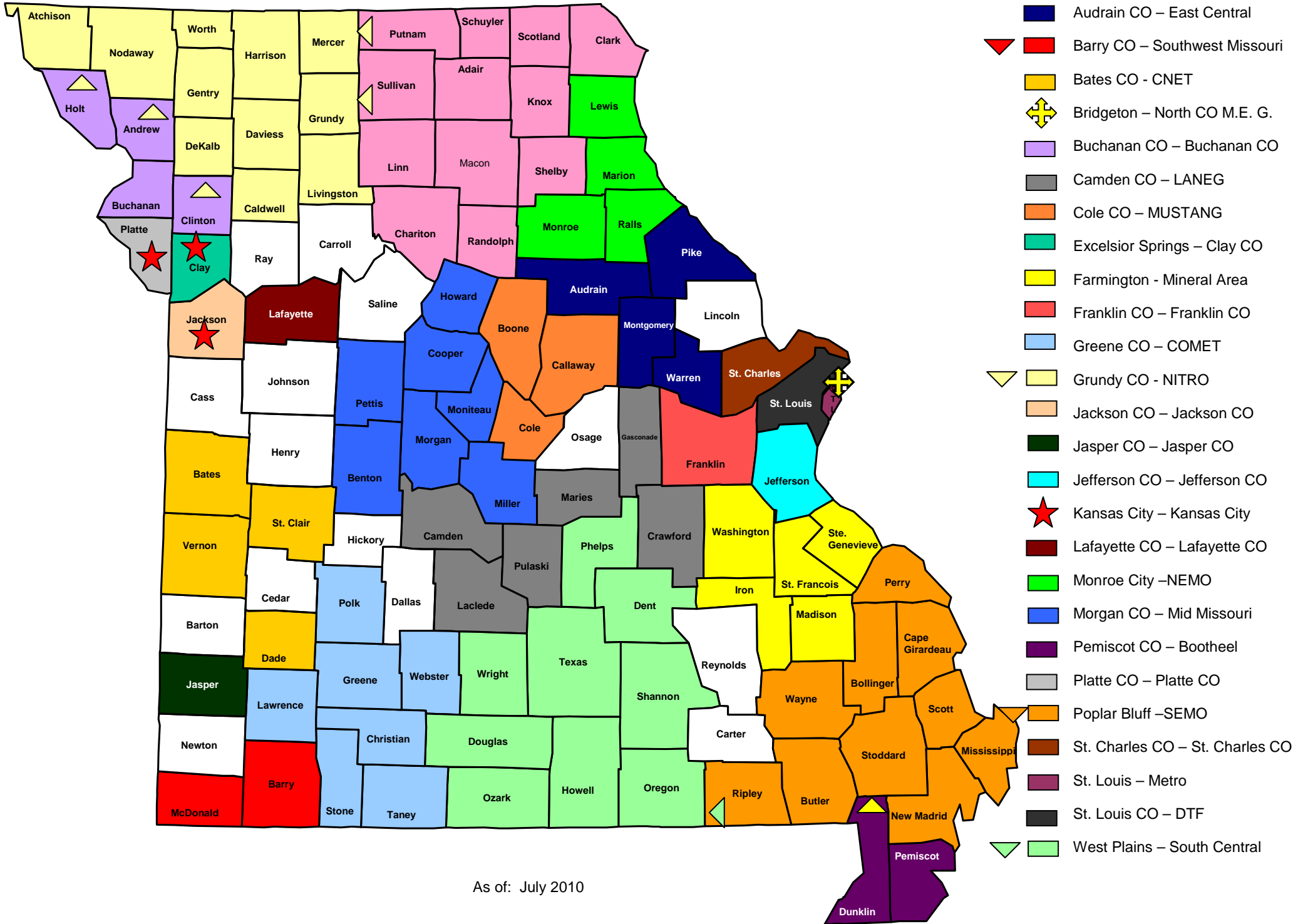
The following report provides summary statistics statewide for the multijurisdictional drug task forces funded by the Department of Public Safety through the end of the second quarter fiscal year 2012.

Statistics are summarized by the number of officers involved, new cases initiated search warrants by disposition, drug and non-drug arrests along with charges, drug purchased and seized, marijuana eradication, and number of methamphetamine labs destroyed.

Fifteen counties in Missouri were not involved in multijurisdictional drug task force as of July, 2010. Counties that were not involved are Barton, Carter, Cass, Carroll, Cedar, Dallas, Henry, Hickory, Johnson, Lincoln, Newton, Osage, Ray, Reynolds, and Saline.

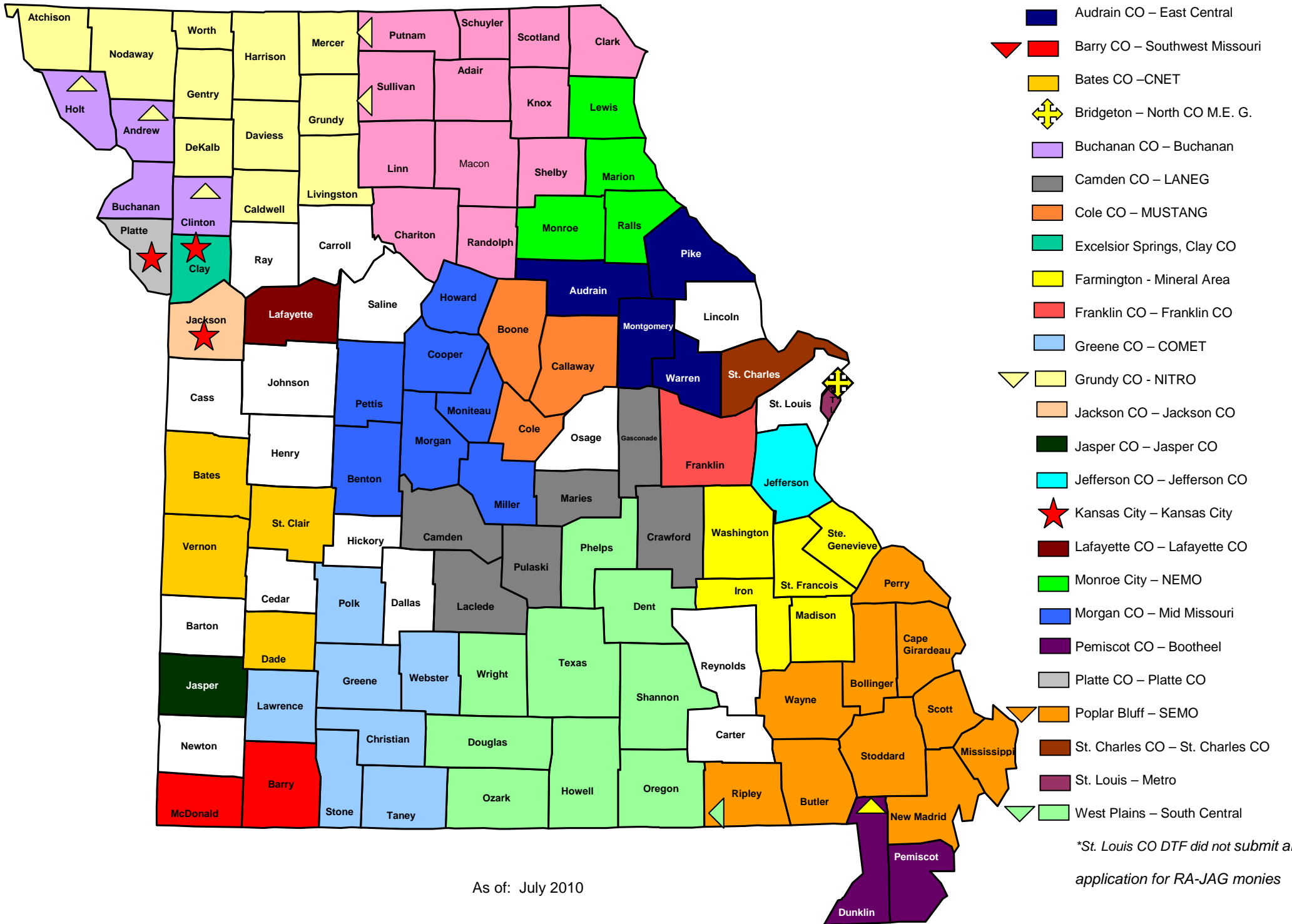

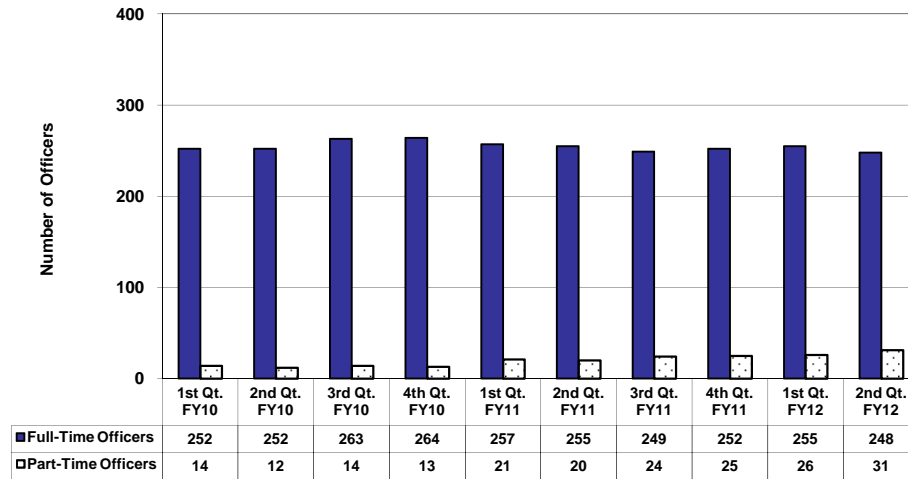

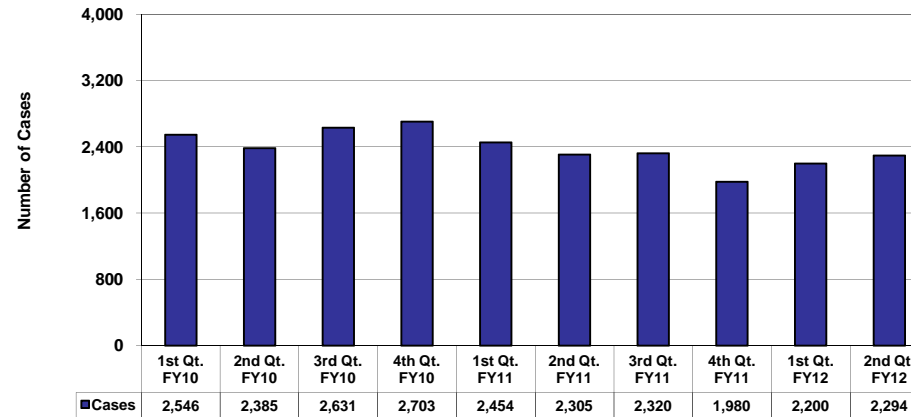
Number of Full/Part-Time Officers Assigned to MJDTF by Quarter

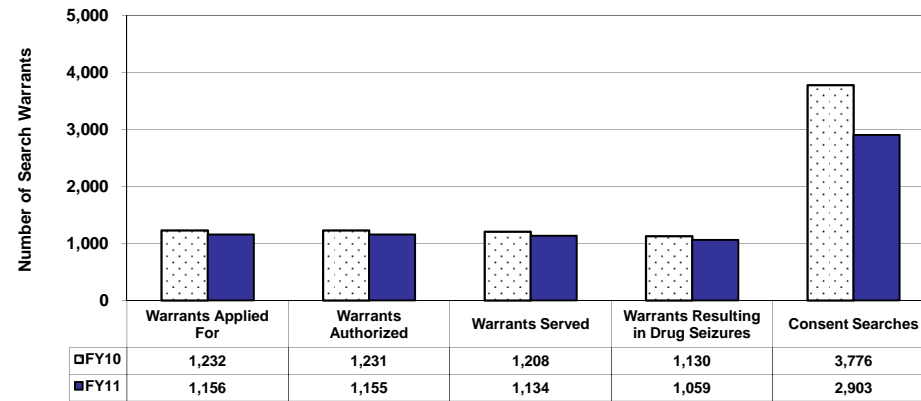
New Cases Initiated by MJDTF by Quarter

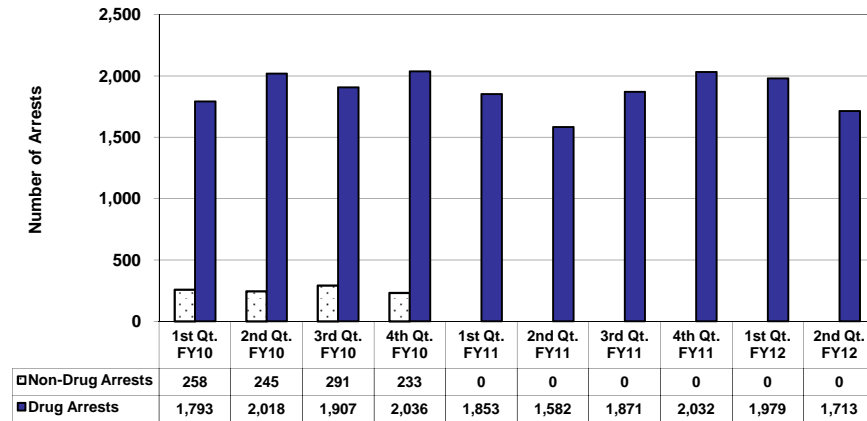

Total Drug and Non-Drug Arrests by Quarter

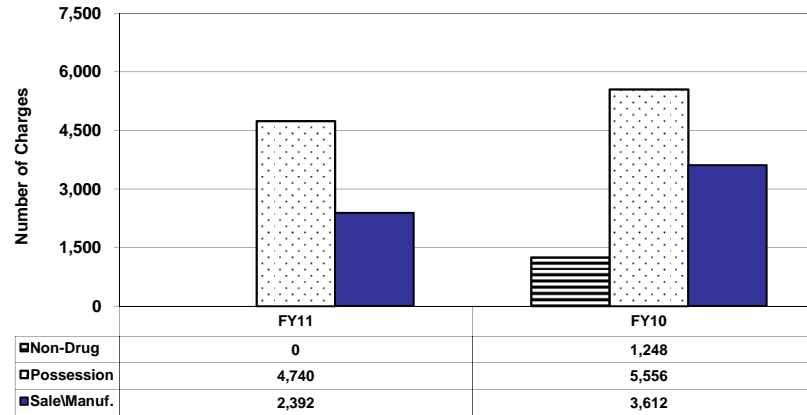

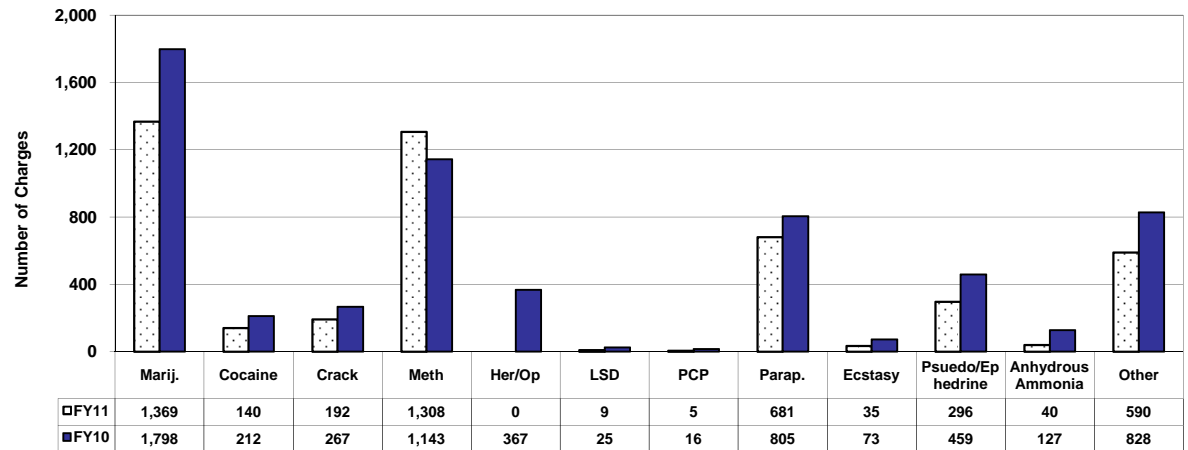
Charges Associated with Arrests by Arrest Type and Fiscal Year

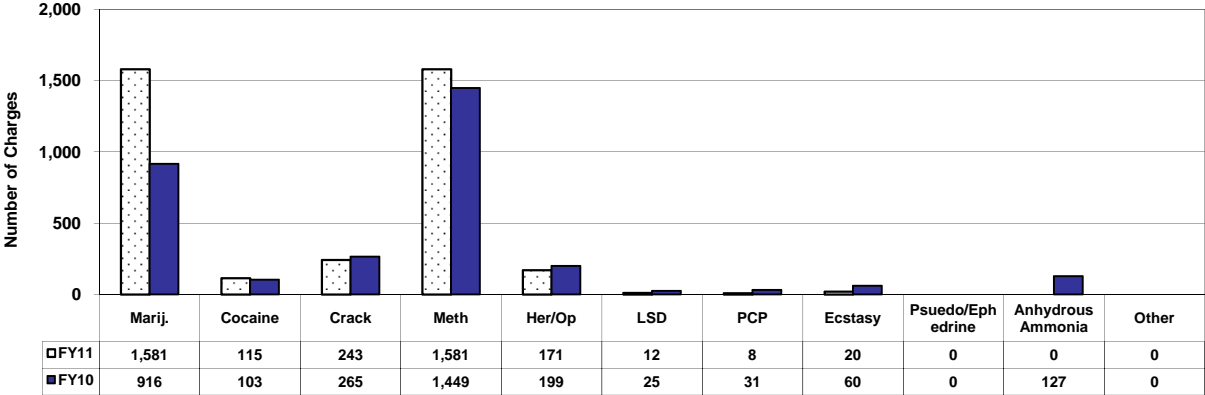
Charges Associated with Possession of Drugs by Drug Type and Fiscal Year

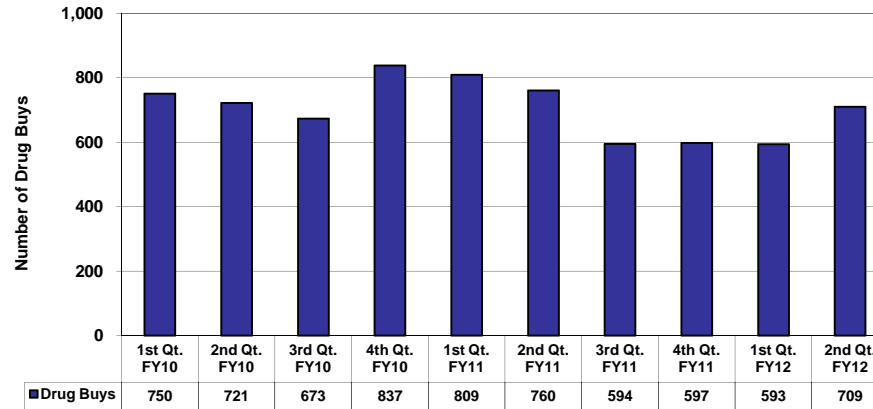

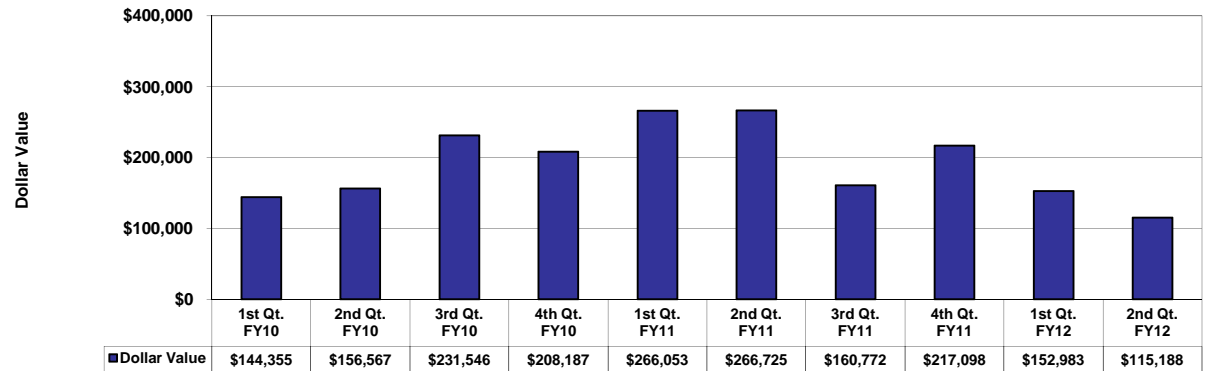
Number of Drug Buys by Quarter

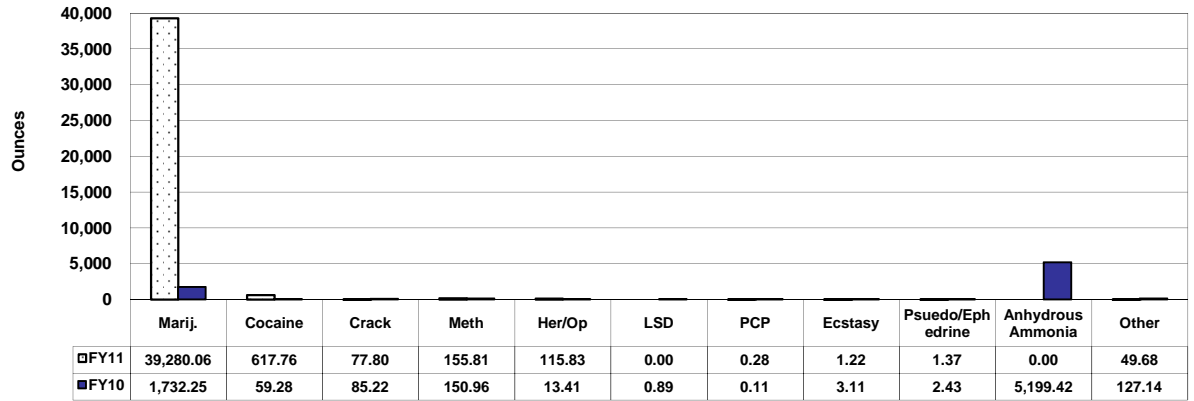
Dollar Value of Drug Purchases by Quarter

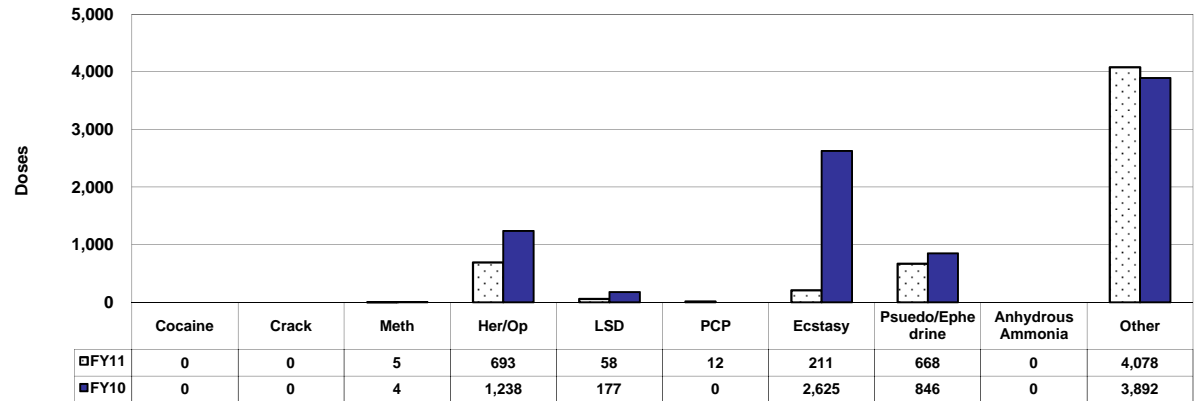
Drug Purchases and Free Samples in Ounces by Drug Type and Fiscal Year

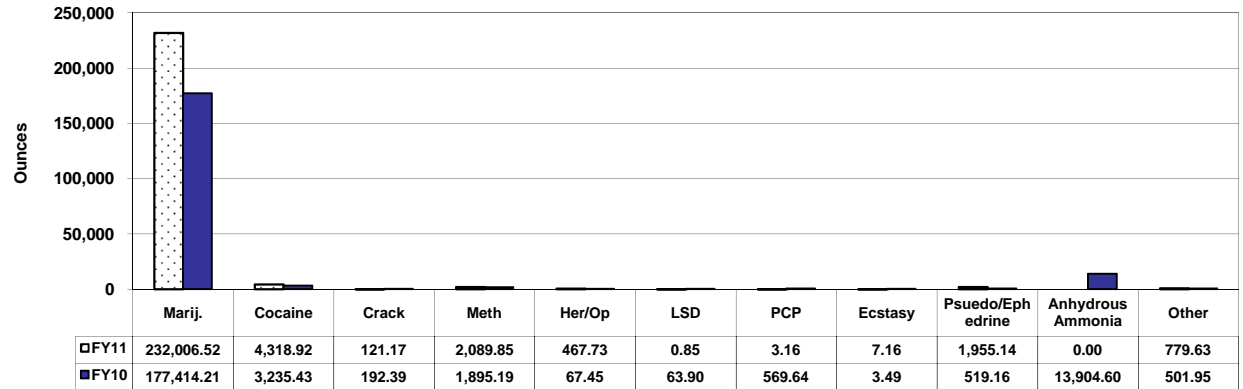
Drug Purchases and Free Samples in Doses by Drug Type and Fiscal Year

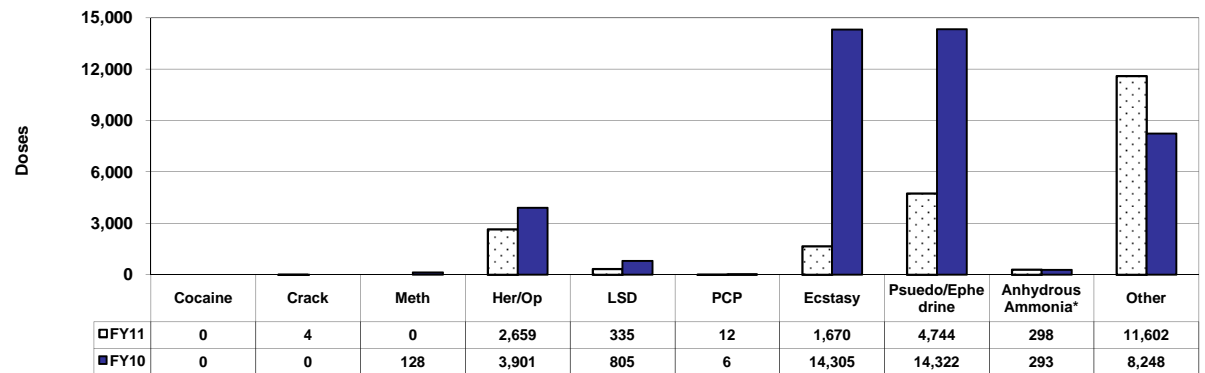
Drug Seizures in Ounces by Drug Type and Fiscal Year

Drug Seizures in Doses by Drug Type and Fiscal Year

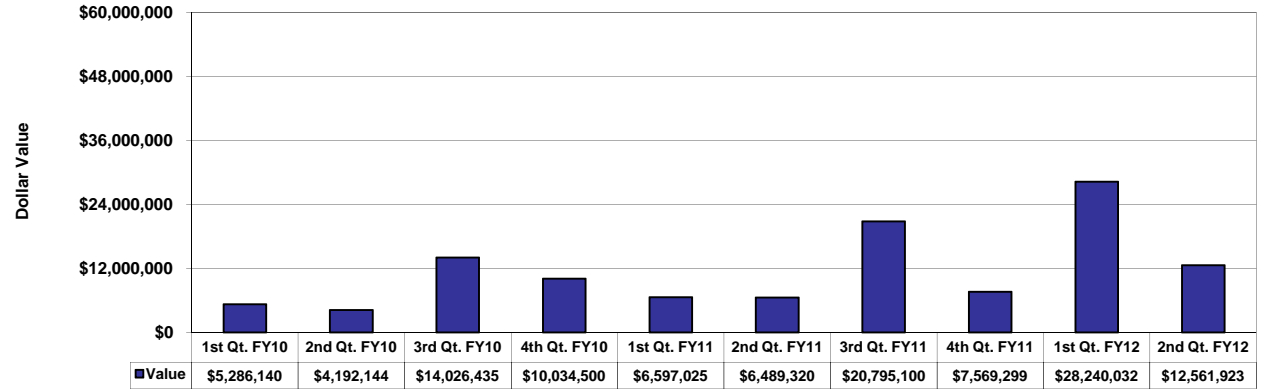

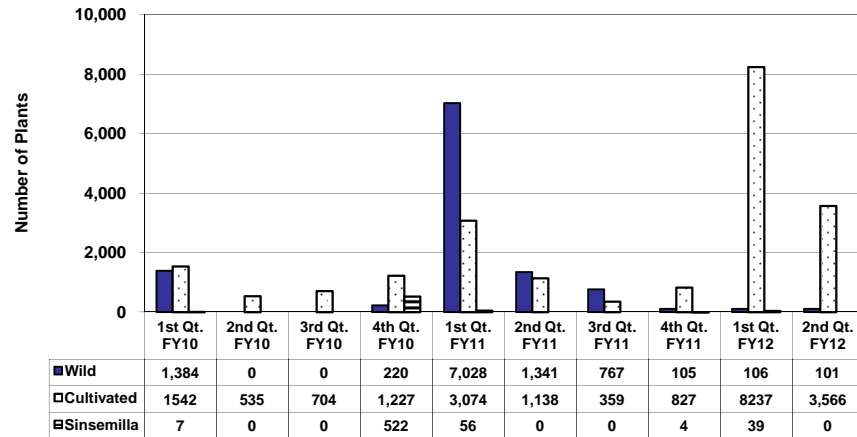
Estimated Dollar Value of Drug Seizures by Quarter

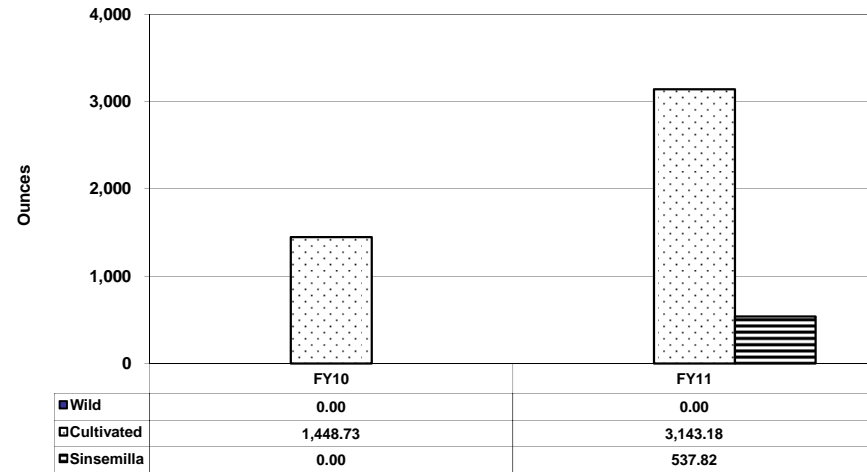

Marijuana Eradication in Ounces* by Fiscal Year

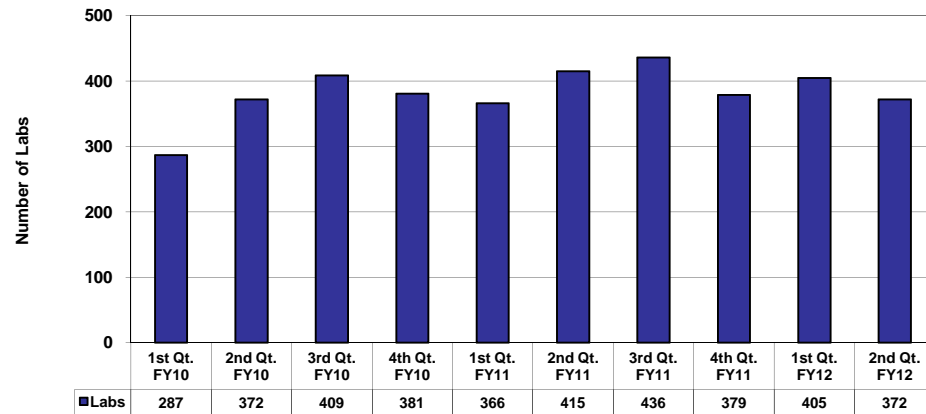

Number of Methamphetamine Labs Destroyed by Quarter

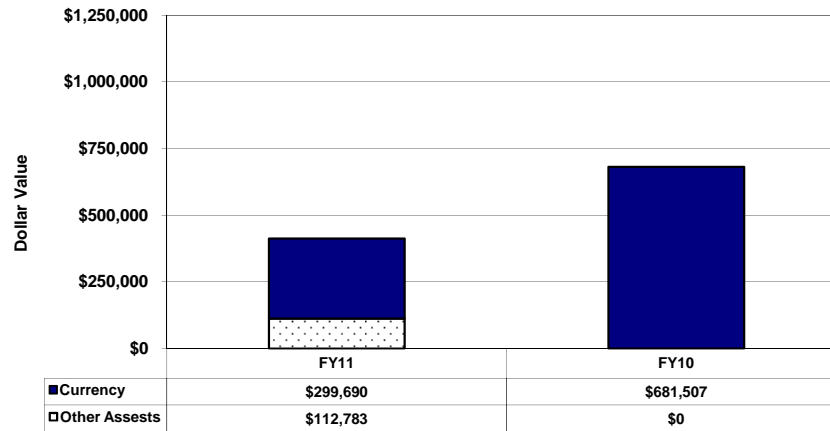
