DESCRIPTION: Multiple Motor Vehicle Inspector positions exist within the Missouri State Highway Patrol's Troop C Headquarters. The official domicile for these positions is St. Louis, Missouri. Motor Vehicle Inspectors are classified as non-exempt under the Fair Labor Standards Act. Although there may not be a current opening at each Motor Vehicle Inspection Station listed below, a hiring register will be maintained for six months in the event that more positions become available.

POSITION SUMMARY: This position audits assigned inspection stations to ensure premises, equipment, and personnel meet statutory and department regulations, policies, and procedures. Work also includes auditing and analyzing various records, inspecting vehicles and school buses, and conducting VIN verifications. The Motor Vehicle Inspector (MVI) interacts with the public and station personnel on a daily basis reference all facets of the Motor Vehicle Inspection program. Extensive travel during working hours is required. An employee in this position may be reassigned or transferred in a Troop at the discretion of the commanding authority.

QUALIFICATIONS: **Motor Vehicle Inspector I:** Possession of a high school diploma or equivalent. **Motor Vehicle Inspector II:** Possess one year experience as a Motor Vehicle Inspector I with the Missouri State Highway Patrol. **Motor Vehicle Inspector III:** Possess three years of experience as a Motor Vehicle Inspector (must have served at least two years as a Motor Vehicle Inspector II).

NECESSARY SPECIAL REQUIREMENTS: Must be at least twenty-one years of age at the time of employment.

Must possess and maintain a valid driver license.

Must be able to successfully complete the Basic Motor Vehicle Inspector's School as approved by the Superintendent of the Missouri State Highway Patrol.

Shall not have been convicted or have any indictment or information pending for any offense involving moral turpitude.

SALARY RANGE (Semi-monthly): The minimum starting salary is \$1,270.00; however, salary may be commensurate with experience.

Interview boards are tentatively scheduled for the week of May 24, 2021. The tentative start date for these positions is within 30 days of the interview.

ADDITIONAL INFORMATION: Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a background investigation and Patrol administered drug test.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
