DESCRIPTION: A Clerk Typist position exists within the Missouri State Highway Patrol's Troop A Headquarters. The official domicile for this position is Lee's Summit, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: This position performs routine clerical work while following well-established procedures, which can be readily learned by on-the-job training. Detailed instructions are given at the beginning of work on subsequent new assignments. The employee is expected to exercise discretion in handling sensitive and confidential information.

QUALIFICATIONS: **Clerk Typist I:** Possession of a high school diploma or equivalent. **Clerk Typist II:** Possession of a high school diploma or equivalent and possess one year experience as a Clerk Typist I or comparable experience. **Clerk Typist III:** Possession of a high school diploma or equivalent and possess two years experience as a Clerk Typist II or comparable experience.

Possess the skill to type at a rate of 40 words per minute with ten (10) errors or less.

SALARY RANGE (Semi-monthly): The minimum starting salary is \$1,029.00; however, salary may be commensurate with experience.
