## TITLE: COMPUTER INFORMATION TECHNOLOGIST TRAINEE, I, II, or III (Technical Support Unit)

**DESCRIPTION:** A Computer Information Technologist position exists within the Technical Support Unit of the Missouri State Highway Patrol's Criminal Justice Information Services Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

**POSITION SUMMARY:** This position provides technical and professional work in the support and coordination of computer information technology (CIT) services and activities. An employee in this position receives formal and/or on-the-job training in providing technical support in personal computer (PC) administration and end-user support focused in installation, maintenance, and administration of a critical public safety data center infrastructure requiring high availability to maintain agency operations and life safety. Work is focused on assisting with the implementation and maintenance of public safety computing equipment, to include operation of a 24/7/365 call center. This position serves as Tier 1 support for the Technical Support Unit.

**<u>SALARY RANGE (Semi-monthly)</u>**: The minimum starting salary is \$1,385.00; however, salary may be commensurate with experience.
