## TITLE: TEMPORARY PROFESSIONAL

**DESCRIPTION:** A Temporary Professional position exists within the Missouri State Highway Patrol's Commercial Vehicle Enforcement Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act. *This position is approved for 1,000 hours of work during a 12-month period.* 

**POSITION SUMMARY:** An employee in this position provides administrative and secretarial support in the Commercial Vehicle Enforcement Division (CVED) and maintains a close and highly responsive relationship to the day-to-day activities of the supervisor and staff. Work includes varied clerical and secretarial duties requiring knowledge of office routine and an understanding of departmental procedures. The employee is expected to exercise judgment and initiative in the performance of assigned duties; however, general supervision is provided by the division director.

**QUALIFICATIONS:** Possession of a high school diploma or equivalent and possess at least five years clerical experience with the Patrol (two years of this experience must be at Clerk Typist III, Stenographer III, or higher); or possess at least seven years experience as a Secretary, Office Manager, or responsible clerical work.

### **NECESSARY SPECIAL REQUIREMENTS:** Completion of a typing test.

Must be able to obtain and maintain MULES certification with six months of hire date.

<u>APPLICATION PROCEDURE</u>: Individuals, including current Patrol employees, interested in this position must visit our website at <u>https://statepatrol.dps.mo.gov/</u> to complete and submit an <u>application</u> and typing test (<u>http://mshp-hrd.AssessTyping.com</u>) prior to the application deadline. Resumes will not be accepted in lieu of the application. Individuals who have previously completed an application must access their profile in the system to re-apply.

The tentative start date for this position is within 30 days of the interview.

**ADDITIONAL INFORMATION:** Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a background investigation and Patrol administered drug test. The Missouri State Highway Patrol is a Drug Free Workplace.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
