TITLE: DRIVER EXAMINER I, II, OR III

DESCRIPTION: Multiple Driver Examiner positions exist within the Missouri State Highway Patrol's Troop F Headquarters. The official domiciles for these positions are listed below. Driver Examiners are classified as non-exempt under the Fair Labor Standards Act. <u>Although there may not be a current opening at each Driver Examination Station listed below, a hiring register will be maintained for six months in the event that more positions become available.</u> Click <u>HERE</u> to view our employee benefits.

Jefferson City Driver Examination Station - Jefferson City, Missouri

Jefferson City Traveling Driver Examination Crew 1 and 2 - serves the following Driver Examination Stations: California, Camdenton, Eldon, Fulton, Hermann, Jefferson City, Linn, Owensville, Versailles

Columbia Driver Examination Station - Columbia, Missouri

Columbia Driver Examination Travel Crew 3 - serves the following Driver Examination Stations: Boonville, Columbia, Fayette, Mexico, Montgomery City

<u>POSITION SUMMARY</u>: This position is responsible for conducting a variety of driver license examinations to determine the eligibility of individual applicants for licensure. The employee interacts with the public on a daily basis reference all facets of the driver examination process.

<u>QUALIFICATIONS</u>: The following represents the minimum qualifications used to accept applicants, provided that equivalent substitution will be permitted in case of deficiencies in either experience or education.

Driver Examiner I: Possession of a high school diploma or equivalent. **Driver Examiner II**: Possession of a high school diploma or equivalent and possess one year experience as a Driver Examiner I with the Missouri State Highway Patrol. **Driver Examiner III**: Possession of a high school diploma or equivalent, and possess three years experience as a Driver Examiner with the Missouri State Highway Patrol (must have served at least two years as a Driver Examiner II).

<u>NECESSARY SPECIAL REQUIREMENTS</u>: Must never been convicted of a felony or any crime involving moral turpitude or have any indictment or information pending for any offense involving moral turpitude.

Must be at least twenty-one years of age at the time of employment.

Must possess or obtain and maintain a valid driver license.

Must be able to successfully complete the Driver Examination Basic School as approved by the Superintendent of the Missouri State Highway Patrol in Jefferson City, Missouri, as soon as scheduling will allow, preferably within 12 months of employment.

Driver Examiners assigned to a traveling crew may be required to furnish a vehicle to transport the Examination Team and all required equipment. The state mileage rate will be used to reimburse employees for expenses incurred in performing job-related travel.

<u>SALARY RANGE (Semi-monthly)</u>: The minimum starting salary is \$1,368.00; however, salary may be commensurate with experience.

<u>APPLICATION PROCEDURE</u>: Individuals, including current Patrol employees, interested in this position must visit our website at <u>www.statepatrol.dps.mo.gov</u> to complete and submit an <u>application</u> prior to the application deadline. Resumes will not be accepted in lieu of the application. Individuals who have previously completed an application must access their profile in the system to re-apply.

The tentative start date for this position is within 30 days of the interview.

ADDITIONAL INFORMATION: Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a background investigation and Patrol administered drug test. The Missouri State Highway Patrol is a Drug Free Workplace.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
