TITLE: TEMPORARY TECHNICAL

DESCRIPTION: A Temporary Technical position exists within the Missouri State Highway Patrol's Fleet and Facilities Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act. *This position is approved for 1,000 hours of work during a 12-month period.*

POSITION SUMMARY: This position is focused in performing mechanical repair, but may also perform collision repair and refinishing on patrol vehicles. Duties also include cleaning and maintaining the work area as well as ordering and picking up parts and supplies. Work is performed under general supervision.

<u>QUALIFICATIONS</u>: The following represents the minimum qualifications used to accept applicants, provided that equivalent substitution will be permitted in case of deficiencies in either experience or education.

Possession of a high school diploma or equivalent, and successful completion of a two-year automotive collision repair course or two years of experience in a position where the primary responsibility is automotive collision repair.

NECESSARY SPECIAL REQUIREMENTS: Possess or obtain and maintain a valid Driver's License.

Must be at least eighteen years old at the time of appointment.

<u>SALARY RANGE (Semi-monthly)</u>: The minimum hourly rate is \$19.30; however, salary may be commensurate with experience.

<u>APPLICATION PROCEDURE</u>: Individuals, including current Patrol employees, interested in this position must visit our website at https://statepatrol.dps.mo.gov/ to complete and submit an application prior to the application deadline. Resumes will not be accepted in lieu of the application. Individuals who have previously completed an application must access their profile in the system to re-apply.

The tentative start date for this position is within 30 days of the interview.

<u>ADDITIONAL INFORMATION</u>: Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a background investigation and Patrol administered drug test. The Missouri State Highway Patrol is a Drug Free Workplace.
