**POSITION DESCRIPTION:** This position is responsible for receiving, processing, and disseminating motor vehicle and boating crash records/data relating to the Statewide Traffic Accident Records System (STARS), U.S. Coast Guard's Boating Accident Report Database (BARD), and Accident Request Tracking Systems. Personnel process incoming manual and electronic records based on various report standards/rules and/or database field specifications, return incorrect or incomplete records, answer technical questions pertaining to the aforementioned systems and reporting requirements of crash reports, and review existing records for conflicting and/or erroneous information. Personnel also process requests for STARS or BARD records/data in accordance with federal and state laws and Patrol/division policies. Close supervision is provided by a supervisor who reviews work for overall completeness, accuracy, and adherence to schedules. This position is classified as non-exempt under the Fair Labor Standards Act. This position is approved for 1,000 hours of work during a 12-month period.
