**POSITION DESCRIPTION:** This is a temporary position where the employee is responsible for conducting a variety of driver license examinations to determine the eligibility of individual applicants for licensure. The employee interacts with the public on a daily basis reference all facets of the driver's examination process. Decisions are made relative to passing or failing of applicants based on well-defined guidelines. An employee in this position may be assigned or transferred from one examination site or CDL test site to another as needed within a troop. An employee in this position *cannot* administer driving skills tests. Temporary Driver Examination Clerks perform front desk operations to allow the Driver Examiners to conduct more driving tests, provide better customer service, reduce wait times, and improve work flow. Work is performed under general supervision. This position is classified as non-exempt under the Fair Labor Standards Act. *This position is approved for 1,000 hours of work during a 12-month period*.
