**POSITION DESCRIPTION:** An employee in this position is accountable for developing, coordinating, implementing, and instructing training courses and programs designed to prepare law enforcement officers for operation of fixed-wing and/or rotary-wing aircraft, assist agency pilots with maintaining or developing their proficiency level, and to formulate and implement training program plans, policies, and procedures. Work includes, but is not limited to, providing ground and flight instruction to agency pilots, coordinating flight schedules, develop and conduct performance assessments and maintain associated training records, develop and implement plans, policies, and standard operating procedures for aviation training programs within the agency. Plans and conducts all weather transportation flights and general utility flights as pilot-in-command or second-in-command and/or serves as pilot-in-command or secondin-command, for maintenance and mission equipment check flights, maintenance and mission relay flights, reposition flights and/or passenger flights, which may contain secured ammunition and/or firearms. An employee in this position will evaluate long term training needs and make recommendations to the Division Director, and take action to ensure agency aviation continuity of operations in pilot staffing. Work is performed under general administrative direction. Employees may also direct and review the work of lower-level employees, in areas such as payroll and related actions. This position is classified as exempt under the Fair Labor Standards Act.
