An employee in this position may be assigned or transferred from one examination site or CDL test site to another as needed within a troop. An employee in this position <u>cannot</u> administer driving skills tests. Work is performed under general supervision.

QUALIFICATIONS: Graduation from high school or possess a GED.

NECESSARY SPECIAL REQUIREMENTS:
