Resumes will not be accepted in lieu of the application. Individuals who have previously completed an application must access their profile in the system to re-apply. A Computer Information Technology Specialist internal process (Special Order 03-10) is not being conducted, therefore all eligible internals must apply.

Interview boards are tentatively scheduled for the week of June 19, 2017. The tentative start date for this position is within 30 days of the interview.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
