DESCRIPTION: A Clerk Typist position now exists within the Missouri State Highway Patrol's Troop C Headquarters. The official domicile for this position is Weldon Spring, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: This position performs typing and clerical work of ordinary difficulty. An employee of this class performs routine office work, which follows well-established procedures, which can be readily learned by on-the-job training. Detailed instructions are given at the beginning of work on subsequent new assignments. An employee in this class is closely supervised.

QUALIFICATIONS: **Clerk Typist I:** Graduation from high school or possess a GED. **Clerk Typist II:** Graduation from high school or possess a GED and one year experience as a Clerk Typist I or comparable experience. **Clerk Typist III:** Graduation from high school or possess a GED and possess at least two years experience as a Clerk Typist II or comparable experience.

Possess the skill to type at a rate of 40 words per minute with ten (10) errors or less.

SALARY RANGE (Semi-monthly): The minimum starting salary is \$972.00; however salary may be commensurate with experience.

Interview boards are tentatively scheduled for the week of July 10, 2017. The tentative start date for this position is within 30 days of the interview.
