DESCRIPTION: This Driver Examiner I, II, or III position is assigned to Troop D Headquarters. The official domicile for this position is Joplin, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: This is an entry-level position where the employee is responsible for conducting a variety of driver license examinations to determine the eligibility of individual applicants for licensure. The employee interacts with the public on a daily basis reference all facets of the driver examination process. An employee in this position may be assigned or transferred from one examination site to another as needed within a troop. Work is performed under close supervision.

QUALIFICATIONS: Driver Examiner I: Possess a high school diploma or GED. Be at least 21 years of age. Possess and maintain a valid Driver License. Driver Examiner II: Meet all requirements for Driver Examiner I. plus possess one-year experience as a Driver Examiner I. Driver Examiner III: Possess at least three years experience as a Driver Examiner with the Missouri State Highway Patrol (must have served at least two years as a Driver Examiner II).

NECESSARY SPECIAL REQUIREMENT: Must never been convicted of a felony or any crime involving moral turpitude or have any indictment or information pending for any offense involving moral turpitude.

Must be at least twenty-one years of age at the time of employment.

Must possess or obtain and maintain a valid driver license.

Must be able to successfully complete the Driver Examination Basic School as approved by the Superintendent of the Missouri State Highway Patrol in Jefferson City, Missouri, within 12 months of employment.

Pursuant to General Order 26-04, uniformed civilian employees hired after January 25, 1995, will not have brands or tattoos that a reasonable person would find offensive, such as brands or tattoos depicting or supporting criminal behavior, drug usage, nudity, profanity, promiscuity, subversive groups, bigotry, etc. Applicants will no longer be hired for uniform civilian positions if they have any brands or tattoos on the head, neck, hands, below the upper six-inch portion of the arms, or any other part of the body which would be visible while in uniform.
