QUALIFICATIONS: Driver Examiner I: Graduation from high school or possess a GED. Be at least 21 years of age. Possess and maintain a valid driver license. No convictions of a felony or any crime involving moral turpitude or have any indictment or information pending for any offense involving moral turpitude. **Driver Examiner II:** Meet all requirements for Driver Examiner I, plus possess one-year experience as a Driver Examiner II. **Driver Examiner III:** Possess at least three years experience as a Driver Examiner with the Missouri State Highway Patrol (must have served at least two years as a Driver Examiner II).
