DESCRIPTION: A Clerk Typist position now exists within the Missouri State Highway Patrol's Motor Vehicle Inspection Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: This is an entry-level position where the employee performs typing and clerical work of ordinary difficulty. An employee of this class performs routine office work following well-established procedures, which can be readily learned by on-the-job training. Detailed instructions are given at the beginning of work and on subsequent new assignments. General supervision is received from designated supervisor.

<u>QUALIFICATIONS</u>: Clerk Typist I: Graduation from high school or possess a GED. Clerk Typist II: Graduation from high school or possess a GED and possess at least one year of experience as a Clerk Typist I or comparable experience. Clerk Typist III: Graduation from high school or possess a GED and possess at least two years of experience as a Clerk Typist II or comparable experience.

Possess the skill to type at a rate of 40 words per minute with ten (10) errors or less.

<u>SALARY RANGE (Semi-monthly)</u>: The minimum starting salary is \$972.00; however salary may be commensurate with experience.

<u>APPLICATION PROCEDURE</u>: Individuals, including current Patrol employees, interested in this position must visit our website at <u>www.mshp.dps.mo.gov</u> to complete and submit an <u>application</u> and typing test (<u>http://mshp-hrd.AssessTyping.com</u>) prior to the application deadline. Resumes will not be accepted in lieu of the application. Individuals who have previously completed an application must access their profile in the system to re-apply.

Interview boards are tentatively scheduled for the week of May 21, 2018. The tentative start date for this position is within 30 days of the interview.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature. <u>NOTE</u>: Final selection may be based upon several factors, e.g., results of an oral interview, written examination or exercise, review of past work performance, performance evaluations, and/or candidate's possession of the knowledge, skills, and abilities deemed necessary for successful performance in the job.

Once a job offer has been made, employment with the Missouri State Highway Patrol is contingent upon the successful results of a Patrol administered drug test and favorable background investigation.
