**DESCRIPTION:** A Building and Grounds Maintenance position now exists within the Missouri State Highway Patrol's Troop A Headquarters. The official domicile for this position is Lee's Summit, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

**POSITION SUMMARY:** This is an entry-level position where the employee is responsible for the general care of Patrol buildings and grounds. An employee in this position performs a variety of housekeeping tasks, mowing lawns, snow removal, etc. Work is assigned and performed in accordance with established routines. Instructions are specific in nature and work is subject to close inspection during progress and upon completion.

**QUALIFICATIONS:** **Building and Grounds Maintenance I:** Graduation from high school or possess a GED. **Building and Grounds Maintenance II:** Graduation from high school or possess a GED and possess at least one year experience as a Building and Grounds Maintenance I or comparable experience.

Applicants must also possess and maintain a valid driver license and be at least 18 years old at time of appointment.

**SALARY RANGE (Semi-monthly):** The minimum starting salary is \$1,015.00; however salary may be commensurate with experience.
