DESCRIPTION: A Clerk Typist position exists within the Missouri State Highway Patrol's Troop F Headquarters. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: This position performs routine clerical work while following well-established procedures, which can be readily learned by on-the-job training. Detailed instructions are given at the beginning of work on subsequent new assignments. The employee is expected to exercise discretion in handling sensitive and confidential information.

QUALIFICATIONS: **Clerk Typist I:** Graduation from high school or possess a GED. **Clerk Typist II:** Graduation from high school or possess a GED and possess at least one year experience as a Clerk Typist I or comparable experience. **Clerk Typist III:** Graduation from high school or possess a GED and possess at least two years experience as a Clerk Typist II or comparable experience.

Possess the skill to type at a rate of 40 words per minute with ten (10) errors or less.

SALARY RANGE (Semi-monthly): The minimum starting salary is \$999.00; however salary may be commensurate with experience.
