
TIP SUMMARY: January 2024


In January 2024, Courage2Report received **108** tips.

Compared to last year, (98 tips in January 2023), we saw a 10% increase.


Bullying was the number one most reported tip type this month, same as January 2023.

January 2024 Tip Summary






In the month of January, Wednesday and Thursday were tied for days of the week with the most tips reported. This is a change from last month. Most tips were received on Mondays during December 2023.

HandleWithCare (HWC)

In January 2024, we received **38** HandleWithCare tips.

In January 2023, we received a total of **11** HandleWithCare tips.

HandleWithCare will be live in Adair County very soon.

Did you know? In some areas, HWC includes other First Responders, such as EMS and Fire.

The "HandleWithCare" Model:

If a law enforcement officer encounters a child during a call, that child's information is forwarded to the school before the school bell rings the next day. The school implements individual, class and whole school trauma-sensitive curricula so that traumatized children are "Handled With Care". If a child needs more intervention, on-site trauma-focused mental healthcare is available at the school.

FBI Reports Increase in Hate Crimes at U.S. Schools

After the categories of residence/home and highway/road/alley, school was the third most common location for a reported hate crime offense to occur during the five-year period of 2018 to 2022. Hate crime in school comprised as much as 10 percent of all reported hate crime offenses in the most recently observed year of 2022. Transcending a basic count, this report analyzes the occurrences and fluctuations of hate crimes reported in the school environment from 2018 through 2022, and their specific bias motivations.

The UCR Program provides three school-related options regarding the location where an offense occurred:

- School Elementary/Secondary
 - Defined as institutions for the instruction of children from preschool through 12th grade.
- School College/University
 - Defined as institutions for the higher education of individuals, which gives instruction in specialized fields: community colleges: trade schools.
- School/College
 - Unspecified definition.

Prior to 2010, School/College was the only data value for the location data element indicating a school as the location of a criminal offense and was used for all school locations, regardless of the age or advancement of enrolled students. In 2010, School – Elementary/Secondary and School – College/University were added as data values to distinguish the demographics of the enrolled students at the location of school-related offenses. Although agencies are encouraged to specify Elementary/Secondary or College/University when designating school as the offense location, the original comprehensive School/College location is still an option.

17-year-old alleged 'serial swatter' charged after police say he made threats throughout the country

A 17-year-old "serial swatter" from California is believed to be responsible for hundreds of swatting incidents and bomb threats throughout the United States and is now facing charges in Florida, according to a pretrial detention motion.

Alan Filion was extradited to Florida on January 30 to face charges for a swatting incident at a mosque, according to the Seminole County State Attorney's Office.

Swatting is making a false report to the police with the intention of luring them to a location by saying a violent crime has taken place or is in progress.
