**DESCRIPTION:** This Clerk Typist position is assigned to the Missouri State Highway Patrol's Motor Vehicle Inspection Division. The official domicile for this position is Jefferson City, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

**POSITION SUMMARY:** This is a position where the employee performs typing and clerical work of ordinary difficulty. An employee of this class performs routine office work following well-established procedures, which can be readily learned by on-the-job training. Detailed instructions are given at the beginning of work and on subsequent new assignments. General supervision is received from designated supervisor.

**QUALIFICATIONS:** **Clerk Typist I:** Graduation from high school or possess a GED. **Clerk Typist II:** Graduation from high school or possess a GED AND possess at least one year of experience as a Clerk Typist I or comparable experience. **Clerk Typist III:** Graduation from high school or possess a GED AND possess at least two years of experience as a Clerk Typist II or comparable experience.

Possess the skill to type at a rate of 40 words per minute with ten (10) errors or less.

**SALARY RANGE (Semi-monthly):** The minimum starting salary is \$856.00; however salary may be commensurate with applicable experience and education.
