SLALOM COURSE RULES:

1. All slalom course permits must be approved annually.
2. The slalom course permit holder is responsible for purchasing and maintaining the course buoys.
3. Buoys should be constructed of a type of material that will not injure a skier or damage a boat.
4. Buoys must be maintained properly and of non-hazardous material, or the permit will be revoked.
5. The buoys must be removed each day no later than legal sunset.


APPLICATION REQUIREMENTS:

1. Submit a drawing of the cove (including length and width of the cove), shoreline, docks or obstructions in the vicinity, existing buoys permitted in the area and the placement of the proposed slalom course buoys. The drawing may be submitted electronically or mailed.
2. The application must be filled out completely and signed, or it will be returned to the applicant.
