The Water Patrol Division announces the following information pursuant to Section 306.124 RSMo.

The Water Patrol Division is conducting a public hearing at 6:30 p.m. on Monday, March 16, 2026, at Osage Beach City Hall, 1000 City Parkway, Osage Beach, Missouri, for the purpose of hearing testimony relating to uniform marking of water areas on Lake of the Ozarks in Benton, Camden, Miller, and Morgan counties. All persons having submitted requests will be notified of time and place.

Kristina Ray requests two (2) No Wake-Idle Speed buoys, one (1) placed 100 ft. at a 45° angle from the Northeast corner of the dock, and one (1) placed 100 ft. at a 45° angle from the Southeast corner of the dock located at 53 MM Gravois, Coffman Bend, Camden County. **-Approved with modification.**
